03. The above rates are complete rates including labour, material and scaffolding except GST which will be reimbursed as per actual amount deposited with GST Department by the Contractor. Nothing extra will be paid to Contractor.
04. The Work is to be carried out as per latest CPWD Specifications.
05. No advance payment will be made.
06. Payment will be made through account payee cheque after satisfactory completion of Work and submitting of guarantee bond.
07. Earnest Money amounting to Rs.2000/ has been deposited by me/us (Contractor) with Dr. Ambedkar Memorial Welfare Society Rajasthan and receipt is attached.
08. The DAMWSR has the right to reject any Quotation without assigning any reason.

GUARANTEE BOND

This agreement made this day oftwo thousand..... between M/s (hereinafter called the Guarantor of the one part) and the..... Whereas this agreement is supplementary to the contract (hereinafter called the Contract) dated made between the Guarantor of the one part and Dr. Ambedkar Memorial Welfare Society Rajasthan of the other part, whereby the Contractor, inter alia, undertook to render the buildings and structures in the said Contract recited, completely termite-proof/water and leak-proof. And whereas the Guarantor agreed to give a guarantee to the effect that the said structure will remain termite-proof for three years to be reckoned from the date after the Date of completion of work. During this period of guarantee the Guarantor shall make good all defects and for that matter, shall replace at his risk and cost such wooden members as may be damaged by termites, and in case of any other defect being found he shall render the building termite-proof at his cost to the satisfaction of the Dr. Ambedkar Memorial Welfare Society Rajasthan, and shall commence the works of such rectification within seven days from date of issuing notice from the Dr. Ambedkar Memorial Welfare Society Rajasthan calling upon him to rectify the defects, failing which the work shall be got done by the Dr. Ambedkar Memorial Welfare Society Rajasthan by some other Contractor at the Guarantor's cost and risk, and in the later case the decision of the Dr. Ambedkar Memorial Welfare Society Rajasthan as to the cost recoverable form the Guarantor shall be final and binding. That if the Guarantor fails to execute the anti-termite treatment or commits breaches hereunder then the Guarantor will indemnify principal and his successors against all loss, damage, cost, expense or otherwise which may be incurred by him by reason of any default on the part of the Guarantor in performance and observance of this supplemental agreement. As to the amount of loss and/or damage and/or cost incurred by the Dr. Ambedkar Memorial Welfare Society Rajasthan, the decision of the Dr. Ambedkar Memorial Welfare Society Rajasthan will be final and binding on the parties.
